Rights Reserved by Artist:

You retain full copyright of your work, subject only to the specific rights given to Global Game Jam in this agreement. By retaining your copyright, you are reserving for yourself, among other things, unlimited rights of electronic distribution, and the right to license the work to other publishers.

Licenses to Global Game Jam

You hereby give to Global Game Jam an ongoing but nonexclusive license to publish and republish the images and text you supply, online or in print or in any other medium, itself or through any publisher. If any image you supply contains your likeness, then you authorize Global Game Jam to publish or republish your likeness in those images under all terms of this agreement. Any such publication of your work will be limited to content supplied as part of the 2018 Global Game Jam 10 book publication. The license granted under this Agreement for the Licensed Software shall be effective starting from the date specified above.

Scope of Licenses

All the above licenses will be worldwide in the English language only, and will endure for all terms of copyright in the paper in all media, including media discovered hereafter.

Warranties

You warrant that you are the sole artist for the work submitted, and generally that you have a complete and unencumbered right to enter into this agreement. You also warrant that the work is original, is not libelous, does not infringe on any other person's or entity's copyright, trademark, patent, or trade secret rights, or otherwise violate applicable law. You agree to indemnify the Global Game Jam organizers against any claim or action alleging facts which, if true, constitute a breach of any of the foregoing warranties.

Multiple Artists

Your names will appear in the book, website and catalog publication in the order listed below. If one of you is to be the corresponding artist, he or she should indicate that fact next to his/her signature.
